Officer Reports

#### **Exchequer**

The Exchequer reported \$20,480.21 in the bank account as of the Dec 31 statement. A check has been written and is outstanding in the amount of \$5.66 to cover taxes for donation made during Baronial Birthday, leaving \$20,474.55 in the account. Doomsday report has been completed, with no issues reported.

Chronicler requested a budget of \$66 for 2021 for necessary mailings of The Argus to members who have requested it. Populace was polled and all were in favor, no opposed.

Web Minister has submitted receipts for reimbursement in the amount of \$28.98 for renewal of web site and domain registration. He has also requested an equal amount that will be incurred in December 2021.

Discussion was held regarding additional budget items that should be considered. No other officer has requested a budget, the Exchequer does not believe she will need anything budgeted. Other items are the storage unit and the PO Box.

Exchequer was asked to coordinate a meeting with the Finance Committee to discuss and approve a 2021 budget.

#### **MOAS**

The MOAS reported continued A&S activities occurring in the Barony. Reminded the populace of the Kingdom challenge to create a favor that lasts until February 27.

### Web Minister

The Web Minister reported getting the remainder of the emails set up for officers and requested deputies. The Exchequer is reporting continued difficulties accessing her baronial Exchequer email account. The Web Minister has offered to meet with her separately to help get her set up.

The previous Seneschal does not recall the password to access the old seneschal's Gmail account to have that email address discontinued.

The web site now has a button to send people who wish to be added to the baronial discussion group to the Google request page.

#### Quartermaster

A letter of intent has been received for the office of the Quartermaster, from HE Sheelaegh. Also, the contract for the storage unit still needs to be transferred from the previous Seneschal to the current one. Letter will be reviewed and discussed with Their Excellencies and a decision will be announced at the March Business meeting.
